Late Shri. B. M. Gogte Industrialist Philanthropist

Shri. B.M. Gogte had humble beginnings and rose to prominence on the industrial map of India. Shri. Balkrishna Madhav Gogte was born on 16th September, 1916, in Tembu Village near Karad in Satara District.

After completing his education he joined the Belagavi Bar in 1935. He started Motor Insurance Co. and thereafter he took up Export Trade of Minerals via Gogte Minerals of Redi, Maharashtra, from where he reached great heights.

He was closely associated with nationally known bodies such as SICOM, and NITIE. He was a member of the Board of East India Hotels, and many other companies. He was a Patron of Karnatak Law Society (KLS).

Raosaheb was an educationist and philanthropist of high order. He contributed to a large extent for the development of education in Belagavi District as else-where in the country. He gave munificent donations to Karnatak Law Society. In recognition of his contributions, KLS named the Commerce College established in 1954, Gogte College of Commerce, and the Engineering College, established in 1979, Gogte Institute of Technology. He also donated towards foundation of Gogte Lecture Series under the Management of KLS.
