A panel discussion on ‘Importance of Internships in Management Education’ was arranged. Students from various management institutions presented their internship projects to the jury. Jury analyzed student’s project on various parameters - Uniqueness of the project, Solution proposed, Company, Internship Rigor, tools and techniques applied, job offers in respective companies, overall presentation of the project, usefulness and soundness of research design.

Cash prizes of Rs 15,000/-, Rs 10,000/- and Rs 5000/- along with Award Certificates were awarded to top three Projects.

A session on “Road Safety and Art of Defensive Driving” by Mr. Amol Tope, Chairman, SUCCEEDSAFE, Mumbai was presented on 5/May/2015. He spoke on significance of making road safety a habit by every single rider and driver. He narrated a few heart stopping incidents of road crashes that are happening on Indian roads. He said on an average 370 people lose their lives every day because of road accidents. He propagated defensive driving tips and stated that it was the primary responsibility of the person riding/driving vehicle to follow traffic rules, good attitude and certain driving discipline such as good maintenance of vehicle, wearing helmet, seatbelts, avoiding overtaking from the left side, respect pedestrians etc. He concluded the session by making audience take an oath on safe driving.



A workshop on “The future is Ready, Are You ?” by renowned Management Consultant, Mr. Anil Thomas, of Mumbai, was presented on 23/Feb/2015. He emphasized three important aspects:

The Law of Compensation - We all get compensated for the value we give, the quality, quantity and complexity of the problems we solve for others.

The speed of change - The speed of change is determined by the knowledge we possess and use of same in all fruitful activities and the technology must be used for the advancement of self, others and society at large.

The law of reciprocity - “You get what you give to others”

Activities were conducted for students by Mr. Thomas to demonstrate these aspects.



A session by Mr. Mahesh Bhirangi, Managing Director, Pragati Engineering Belgaum Private Limited, was presented on 22/April/15. He spoke on his journey as an entrepreneur over periods of time covering uncertain economic cycles. He said that an entrepreneur is the one, who has vision and passion towards his business idea, takes calculated risk with perseverance to ensure profit in business. He believes in values like ethics, quality and excellence. He advised MBA students to have clear idea about their career in which they wish to excel. He concluded his address by saying industry always expects MBA students to have maturity and quick learning ability, so that they can add value to the organization that they serve.



A session by Shri Nanda Kumarji, the editor-in-chief of Kesari, Malayalam weekly on 26th September 2014. He deliberated on the topic “Importance of media and its roles & responsibilities”. He said media plays an important role to create awareness about what is happening around us, across the country & countries abroad. He quoted Mahatma Gandhi for appreciating media for being a powerful vehicle & one of the important pillar of democracy. He concluded his session by saying three important duties of media; 1. Media must use its independent status effectively. 2. Media must bring out the truth to public 3. Media must serve the nation & should not be behind making money or business out of news that sells in the market.



A session by Mr. Shailesh Joshi, Chairman, Amrut Pharmaceuticals, Belagavi was presented on 15th April 2015. Mr. Shailesh Joshi spoke on significance of Ayurveda in our daily life. He spoke about qualities needed to be a successful professional in the insurance sector - Attitude, communication skills, accountability and ethics.

KLS – IMER organized a Conclave on “Brick and Mortar Retailing in an era of E-tailing” on 24th February 2015, in association with TiE-Hubli, for retailers from various sectors where experts from retail sector deliberated on emerging trends in Indian retail followed by panel discussions and interactions. Retailers from both sides of the divide traded ideas and coping strategies, including technology, data analytics, and customer experience stories for those most affected by this onslaught.

The programme began with opening remarks from Shri Rajendra Belgaumkar, Chairman, GC of KLS-IMER. Mr Vinay Pawar, Executive Director, TiE-Hubli, assured all the support for meeting the objectives of the Conclave.

The Key speakers for the programme were Mr. Venu G Somineni, Founder and CEO, MyDeals 247 (The world’s first personalized e-commerce platform) and Mr. Chirant Patil, CEO, Gito.me, an online selling platform. Mr Ashok R Tolanavar from Tolas Electronics, Hubli spoke from retailer’s perspective addressing the challenges faced by Brick and Mortar retailer’s in an era of e-tailing.

There was a Panel Discussion on Voice of Consumers, where in five panellists participated from different cross section of the society, spoke on their experience of online shopping and its advantages and its limitations. Dr. Charantimath moderated this discussion.

This was followed by a Panel Discussion in which retailers and other service providers from Belagavi discussed their successes and problems faced due to online retailing. The panel discussion was moderated by Mr. Parag Saraiya, Director, Bella Vista, Belagavi.

The Research Centre of the Institute conducted a research study on “Impact of retailing on Brick and Mortar retailing in an era of e-tailing” on various retail sectors such as: Ready-made garments; Home appliances; Electronics; Book stores and buying behavior of women and the faculty members presented their research findings.

Many local retailers including women entrepreneurs from Avishkar arranged their stalls in the atrium of our building lending it the air of a bazaar. The programme was co-ordinated by Dr Poornima Charantimath, Dr Arif Shaikh and Mr Shrirang Deshpande, faculty members of the institute.

The conclave was attended by around 100 retailers from in and around, Belagavi, Hubli and Dharwar. A majority of the attendees were very appreciative of KLS IMER’s efforts in dreaming up and executing a Conclave on this topical and disruptive business issue.


